(1) Life, Accident and Health (including endowments, annuities & all other forms of contracts)

- (a) 1st \$2,000 gross annual premiums - \$10
(b) Each additional \$10,000 or fraction thereof in excess of \$2,000 - \$70
(c) Maximum license shall not exceed twenty-one thousand dollars

(2) Gross Fire, Marine, Transportation, Casualty, Surety, Fidelity, Indemnity, Workmen's Compensation, Employer's Liability, Property Damage, Livestock, Vehicle, Automatic Sprinkler or other Premiums

- (a) Gross receipts not to exceed \$2,000 - \$40
(b) Gross receipts more than \$2,000 and not exceeding \$4,000 - \$60
(c) Gross receipts more than \$4,000 and not exceeding \$6,000 - \$80
(d) When gross receipts exceed \$6,000, the additional license shall be \$70 for each \$10,000 or fraction thereof in excess of \$6,000
(e) Maximum license shall not exceed \$9,000

(3) Plate Glass and Steam Boiler Inspection Companies

- (a) If business is confined to plate glass or steam boiler you pay only one-third (1/3) of the licenses as graded under (2) above.

Note: All rates for (2) and (3) above are reduced to one-third of above if one-sixth of total admitted assets are invested in bonds of this state or a political subdivision thereof or in mortgages on property of this state or real estate or policy loans or other loans to resident corporations in homestead building and loan stocks and a sworn statement is filed with the tax collector.
